Sir,

I am directed to refer to the provisions prescribed under Section 12C of the Homoeopathy Central Council Act, 1973 and regulations made thereunder. In order to verify the compliance of availability of standards by the College, the Board of Governors to CCH has conducted inspection of Yenepoya Homoeopathic Medical College & Hospital & Hospital, Dist- Dakshina Kannada, Karnataka on 25.03.2019 and furnished recommendation for allowing admission in 1-BHMS course for the session 2019-20 with intake capacity of 100 in existing UG(BHMS) course.

2. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, recommendations of the Board of Governors to CCH, permission of the Central Government is hereby granted to Yenepoya Homoeopathic Medical College & Hospital & Hospital, Dist- Dakshina Kannada, Karnataka for continuing admissions in 1- BHMS course with intake capacity of 100 seats during the academic year 2019-20.

3. It is further informed that 15% of undergraduate and 15% of post graduate seats of the permitted intake capacity of 60 UG seats and 10 PG seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by the Central Government and counseling for the remaining 85% seats shall be conducted by the concerned State Government. If any seats are not filled up in the Central Counseling, the same shall be transferred to the concerned State Government to admit students as per their rules/ reservation policies/norms. The permission of the college stands withdrawn if the college fails to co-operate with the Central counseling for all India quota or the students admitted thereunder.

4. Admissions made in violation of the above conditions will be treated as irregular and action will be initiated under HCC Act & Regulations made thereunder.



5. Discrepancies, if any, may be immediately brought to the notice of CCH and the Central Government.

6. The College has to comply with the full requirements of HCC (MSR) Regulations, 2013 by 31<sup>st</sup> December, 2019 for continuing admissions during the subsequent year. A copy of the compliance report shall be submitted by the college to CCH under intimation to this Ministry. Subsequently, CCH shall verify the compliance well in time for considering the admissions during the Academic Year 2020-21 and furnish the recommendation to the Central Government.
